**Description**

Crestvue Ambulance Service is currently accepting resumes for casual Primary Care Paramedics (PCP). Crestvue Ambulance is a privately contracted ambulance service that provides paramedic service for the Saskatchewan health Authority (SHA) to Yorkton and area. Yorkton is situated 3.5 hours east on Hwy 16 of Saskatoon and 2 hours north east of Regina on Hwy 10 in east central Saskatchewan with a population of over 20,000 ([www.yorkton.ca](http://www.yorkton.ca)). The organization employees between 20 to 25 paramedics in partnership with the Health Sciences Association of Saskatchewan union.

Crestvue's diverse paramedic team consists of Advanced Care Paramedics, Intermediate Care Paramedics and Primary Care Paramedics. These paramedics respond to approximately 2600 to 3000 emergency and non-emergency requests per year.

**Applicants**

Applicants must hold a valid Saskatchewan College of Paramedics (SCOP) and a valid class 4 or greater Saskatchewan Drivers License with a strong understanding of the following:

- Saskatchewan College of Paramedics protocols with the understanding of the full scope of practice applicable to the level of training
- Saskatchewan Ambulance Act and Regulations
- Traffic Safety Act
- Paramedic Act
- Health Information Protection Act

Applicants must also be able to meet the following accountabilities and requirements of the organization:

- Ability to work within the full scope of practice.
- Excellent verbal and written communication.
- Able to adapt to an unpredictable workload.
- Able to collaborate and function as member of a health care team in all areas of the prehospital and hospital settings.
- Demonstrate professionalism, honesty and integrity
- Adhere to the vision, values, policies, procedures and direction of Crestvue Ambulance Service and the Saskatchewan Health Authority.
- Maintain good attendance record and being fit for duty is strongly recommended.

As a part of the Crestvue paramedic team the practitioner will be accountable to:

- Perform all required shift quality assurance checks, duties and responsibilities for the maintenance, upkeep and performance of ambulance/support vehicles, equipment, facilities, care of patients and that of the organization's image.
- Perform infectious control assurances of ambulance/support vehicles equipment facilities to insure a safe and healthy work environment by limiting cross contamination.
- Adhere to the Saskatchewan College of Paramedics license renewal requirements to maintain scope of practice through attending continuing educations.
- Promote a healthy and positive team-based workplace.
- Complete all documentation in a professional and timely manner to ensure a high standard of patient care, quality assurance and legal requirements.
- Ensure the safety and protection of all patients and their information.
- Collaborate and communicate professionally with paramedic communication centers in all paramedic responses
- Comply with the organizations, SHA and communication centers guidelines/standards to responding to emergency and non-emergency requests.
- Always ensure that you are fit for duty, maintain good hygiene and professionalism in the public while representing the Crestvue organization.

Crestvue Ambulance Service looks forward to receiving your application and the possibility of developing of a future relationship with our paramedic team members. Successful candidates will be contacted by phone and informed of the next requirements of the process. All resumes will be kept on file for further opening within the organization for a period of 1 year.
